

**“AID FOR UKRAINE”
CHARITY EVENT
ORGANISED BY THE REHASPORT CLINIC FOUNDATION**

§ 1 [DEFINITIONS]

The following terms used in these Regulations shall have the meaning as follows:

- 1) “Event” – charity event named “AID FOR UKRAINE” organised by the REHASPORT CLINIC Foundation;
- 2) “Organiser” - REHASPORT CLINIC Foundation with registered seat in Poznań, at ul. Górecka 30, 60-201 Poznań, entered into the register of social and professional organisations, foundations and public healthcare institutions with the KRS no. 0000410877. Its registry file is kept by the District Court for Poznań - Nowe Miasto i Wilda in Poznań, VIII Commercial Department. KRS no. 0000410877, Tax Identification Number [NIP] 7792403986, REGON no. 302039184;
- 3) “Regulations” - this document specifying especially the Event’s rules and conditions as well as the Organiser’s rights and duties;
- 4) “Donation” – amount constituting a donation within the meaning of the Civil Code regulations, given by the Donator to the Organiser in relation to the Event.

§ 2 [GENERAL CHARITY EVENT RULES]

1. The REHASPORT CLINIC Foundation is the Organiser of the “AID FOR UKRAINE” charity event.
2. The purpose of the event is to gather funds and specialist medical equipment for the victims of the war in Ukraine, including providing orthopaedic and rehabilitation aid in Poland, targeted purchases of medical products for Ukrainian specialist orthopaedic and rehabilitation treatment centres as well as coordination of relief measures of Polish and international orthopaedic associations and foundations.
3. The money donated shall be used to fund orthopaedic and rehabilitation aid for the victims of war.
4. The charity event starts on 28 February 2022 and ends on 31 December 2022.
5. The Foundation shall provide the following bank accounts to gather funds:

 - d) Payments in **USD**: PL 72 2490 1057 0000 9901 5946 7694 (SWIFT: ALBPPLPW)
6. All funds gathered on the aforementioned bank accounts within the time specified in § 2 paragraph 4 of these Regulations shall be transferred for the objectives specified in § 2 paragraph 2 of these Regulations.
7. The Organiser shall transfer the gathered funds as a donation. The donation shall be transferred as per the Event’s objectives.
8. All payments made after 31 December 2022 shall be donated for the Organiser’s statutory purposes.
9. The donations are non-refundable, except for cases specified in the rules of law.

§ 3 [EVENT PARTICIPANTS]

1. Any natural person with full legal capacity, natural person with limited legal capacity and approval of its statutory representative as well as legal person or organisational unit with legal capacity, without a legal personality, that credits the Foundation's bank account during the Event's term according to § 2 of these Regulations can be the Event's Participant.
2. Each Event's Participant is obliged to read with these Regulations.
3. By making a payment, the Event's Participant accepts the provisions of these Regulations.
4. The Event's Participant shall be able to make a non-cash payment via wire transfer to the bank account number specified in § 2 paragraph 5 of these Regulations and by making a payment to the REHASPORT CLIINC Foundation's PayPal address: https://www.paypal.com/donate/?hosted_button_id=VEVU94HW8RCRJ, as well as to provide medical equipment (including orthopaedic and rehabilitation equipment).

§ 4 [FINAL PROVISIONS]

1. The Regulations are available for review at the Organiser's registered seat and at the REHASPORT CLINIC Foundation's website.
2. The Polish law applies to any legal relations arising in connection with the Event.
3. The court with jurisdiction to resolve disputes between the Foundation and the Users, arising in relation to the Foundation's services provided via the Site shall be the common court with jurisdiction and seat in Poznań - this provision is not binding for the consumers within the meaning of the Civil Code regulations.
